What data is collected/used?

We collect:

- Identification data: surname, first name, business name
- Geographical data: country, postal code
- Contact details: telephone, email
- Reason for Request
- Any other information that you voluntarily share with us via the form.

Why do we collect/use this data?

The personal data collected is used to be part of the annual campaign which consists of interviews on the blog, use of testimonials on the website and/or advertising.

Who is the data controller?

The data controller is PREMIER TECH GROWERS AND CONSUMERS, 1 avenue Premier, (Premier Tech Campus), Rivière-du-Loup, Quebec, Canada, G5R 6C1, (hereinafter "Premier Tech").

What is the legal basis?

The legal basis for processing your personal data is the consent you voluntarily give us by submitting your request to participate in the selection process for our marketing campaigns.

How long will the data be kept?

The data will be kept until you withdraw your consent.

Who are the recipients of the data?
